

Dr. Ryan Bonfiglio chosen as Guest Speaker at TWU Heritage Day



Tennessee Wesleyan University will host Dr. Ryan Bonfiglio as this year's Heritage Day speaker.

Bonfiglio serves at Emory's Candler School of Theology as an Associate Professor in the Practice of Old Testament. He also serves as the Executive Director of The Candler Foundry, an initiative that seeks to make the best of theological learning accessible to the broader public and beyond Candler's formal degree programs.

He holds degrees from Princeton University (BA Chemistry), Princeton Theological Seminary (MDiv), and Emory University (PhD, Old Testament). His research and teaching interests include biblical metaphors, the Ten Commandments, the Bible and poverty, ancient Near Eastern iconography, and various topics in Old Testament theology.

He is the author of *Reading Images, Seeing Texts: Towards a Visual Hermeneutics for Biblical Studies* and is currently working on a book that explores the biblical theology of Sabbath. Bonfiglio was born and raised in Philadelphia and still suffers from a lifelong love of Philly sports team.

Bonfiglio will speak on Monday, February 16, at 7:00 p.m. in the Johnson Event Center located in Colloms Campus Center on the topic "Embracing Rest in a Restless World." He will speak again during Convocation time on February 17 at 11:00 a.m. in Townsend Auditorium on "Made in the Image of Three Mile-an-Hour God." Both events are free and open to the public.

Blount County Probation Officer Arrested Following TBI Investigation

Friday's show includes light hors d'oeuvres with tickets priced at **\$25**, while Saturday's Valentine's Day performance features a full meal with tickets at **\$40**; ticket sales for Saturday ended **Tuesday, Feb. 10** due to catering. Advance ticket purchase is strongly recommended, as performances often sell out.



A Blount County probation officer has been arrested following an investigation by special agents with the Tennessee Bureau of Investigation into allegations of official misconduct.

According to the TBI, agents began investigating James Glenn Dale, 42, in January at the request of 5th Judicial District Attorney General Ryan Desmond. Dale was employed as a probation officer with the East Tennessee Human Resource Agency at the time of the alleged incidents.

During the investigation, agents determined that Dale engaged in sexual contact with a female probationer who was under his supervision.

The Blount County Grand Jury returned indictments last week charging Dale with one count of official misconduct, one count of official oppression, and one count of sexual contact with a probationer. On Tuesday, with assistance from the Blount County Sheriff's Office, Dale was arrested and booked into the Blount County Detention Facility, where bond was set at \$250,000.

The charges and allegations are accusations only. Dale is presumed innocent unless and until proven guilty beyond a reasonable doubt in a court of law. *Source: TBINewsroom.com*

Missing Athens Woman Found Safe, Police Say



Athens police have confirmed that **Karen Martinez**, the 26-year-old woman reported missing earlier this week, has been **found safe**.

Martinez was the subject of a missing person alert issued Monday after family members reported they had not had contact with her since

late July 2025. She was last known to have been in the Athens area, and police noted at the time that Martinez is blind in one eye and has mental health challenges.

The Athens Police Department posted an [update](#) Monday afternoon on the [City of Athens Facebook page](#), indicating that Martinez had been located and was safe. No additional details regarding where she was found or the circumstances surrounding her recovery were released.

Authorities thanked the public for their assistance in sharing the alert and helping spread awareness.
