Cruz Arrested After Weeks-Long Manhunt; Second Suspect Still Sought



After a weeks-long, multi-agency manhunt across Southeast Tennessee, authorities have captured the man accused of a January stabbing in Athens that left one person hospitalized.

David Rodriguez Cruz, 32, was arrested Friday, Feb. 13, during a coordinated operation within the City of Athens. Police Chief Fred Schultz said the arrest was carried out "without incident" using established tactical and safety procedures, and no injuries were reported. Cruz had been wanted for attempted first-degree murder in connection with a Jan. 22nd stabbing in Athens. The victim, whose name has not been released, survived and is recovering. Additional charges are possible as the investigation continues.

While Cruz is now in custody, authorities are still searching for Thomas Larry Burns, 41, who allegedly fled from officers earlier this month during an encounter in the Kinser Road area of Cleveland as police worked to locate one of Cruz's known associates. Investigators say Burns accelerated his vehicle toward officers, prompting a multi-county pursuit through Bradley and Polk counties that ended when the vehicle was found abandoned near Parksville Road in Benton.

Burns is wanted on multiple felony charges, including three counts of aggravated assault on law enforcement, felony evading, and separate theft charges out of Bradley County. Multiple agencies, including the U.S. Marshals Service and Tennessee Highway Patrol, assisted in the search using K-9 units and drones, but **Burns remains at large**. Authorities urge anyone with information to contact the Athens Police Department or call 911, and caution the public not to approach him.

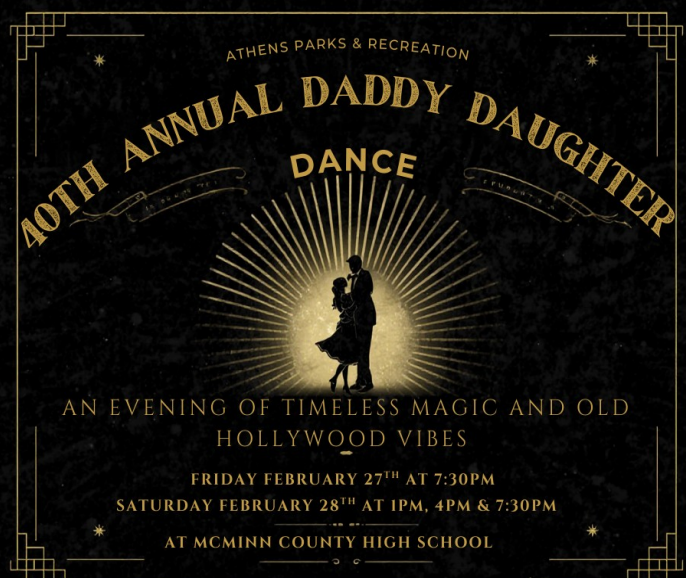

Meigs County Secures \$100,000 for Industrial Park Upgrades



Meigs County has been awarded \$100,000 in state funding to help improve infrastructure at the Meigs County Industrial Park, a move local leaders say will strengthen the county's ability to attract new business and jobs.

State Rep. Dan Howell, R-Cleveland, announced the grant Thursday. The funding comes from the Tennessee Department of Economic and Community Development's Site Development Grant program, an initiative aimed at preparing industrial properties for economic recruitment.

The Site Development Grant program operates under the Rural Economic Opportunity Act, created in 2016 to bolster economic growth in Tennessee's rural communities. The program funds planning, grading, infrastructure and engineering work designed to make sites more marketable to prospective employers.

Meigs County is one of 13 counties selected to receive funding this year, sharing more than \$13 million in total awards statewide. Howell said the grant will help position the industrial park to compete for future projects.

"Site readiness is one of the most important factors in attracting new industry," Howell said. "This investment equips Meigs County for future economic growth and job opportunities and helps place the county on a level playing field when bidding for highly competitive projects."

He also expressed appreciation to Gov. Bill Lee and Economic and Community Development Commissioner Stuart McWhorter for their continued support of rural communities across the state.

Local officials say the funding will support targeted improvements at the industrial park aimed at enhancing its competitiveness and long-term development potential. *Source: [WTVC NewsChannel 9](https://www.wtvcnewschannel9.com)*
